Saturday June 28th, Sunday June 29th, (Set-up Friday, June 27th)

- 1) LGP and Janie Bowthorpe & Crew will not be responsible for any claims, loss, theft or damage to persons or property from any cause whatsoever while premises are being occupied under this agreement and during the dates specified, including the set up day. By signing this contract, you are assuming all risks of personal injury & loss of property and agree to hold LGP, Janie Bowthorpe and crew completely and totally harmless.
- 2) Security will be provided Saturday night only and you agree to any risk.
- 3) Vendor's booth will conform to all appropriate state and local regulations. All personnel working in food booth will have a current Utah Health Department food handler permits.
- 4) Vendors are responsible to collect and report appropriate sales tax. A temporary sales tax license will be issued at no cost at the beginning of the show. The sales tax rate for food in Moab is 8.8%.
- 5) It is required to stay within the confines of your space, as well as not encroach on another vendor's space.
- 6) Only food and beverages may be sold by food vendors; antiques may not be sold by food vendors.
- 7) Tear down or cessation of sales must not occur before 5 pm Sunday afternoon.
- 8) Full payment required to reserve space. No refunds for any reason.
- 9) If this contract is received after all spaces are reserved, your monies will be returned and you will be put on a waiting list.
- 10) LGP reserves the right to restrict, exclude or evict any vendor who does not comply with stated guidelines or causes undue disruption or distraction during the antique show at any time without refund of fee.
- 11) Consumption of alcohol is not permitted.
- 12) I acknowledge that failure to comply with any of the above may cause forfeiture of any or all fees plus immediate expulsion from the Mart and possible legal action against me.
